#### 2. **Deposit Terms**

### To have your \$500.00 refundable reservation list fee accepted, please initial each section below to indicate your agreement with the terms outlined.

2.1 The Adopter understands and agrees that their \$500.00 deposit is refundable if the Breeder is not able to place a puppy in their home within 18 months from the time of deposit. At any point in time and for any reason, the Adopter may change their mind and cancel their reservation list fee for a refund of \$350.00. The Adopter also understands that they may at any time for any reason move their reservation deposit two times to the next two litters planned. Additionally, the Adopter is not guaranteed their puppy of choice or gender of choice; however, they understand that they can continue to defer their place in line and add themselves to future reservation lists until they get the puppy they want and/or need.

By initialing here, you acknowledge and agree to the terms in the section above

2.2 The Adopter understands that the timing of litters is uncontrolled, as well as a successful pregnancy. The Breeder is not able to control the timing of heat cycles. The Breeder also reserves the right to cancel a reservation due to the best interest of the parents involved (the health of the parent dogs is paramount to having a litter). In the event a reservation list (breeding pair) is canceled, the Breeder will provide the Adopter with other upcoming options. Heat cycles and timing are not guaranteed.

By initialing here, you acknowledge and agree to the terms in the section above

2.3 The Adopter understands that clients choose in the order of the reservation list (date deposit was made), and can select any of the puppies available to them at their selection time and placement. If an Adopter is not in attendance nor reachable by phone during their 30-minute selection timeframe (this appointment will be made in collaboration between both client and Breeder), then they will forfeit their placement in line. Missing this appointment will also void the \$350.00 refundable portion of the deposit.

By initialing here, you acknowledge and agree to the terms in the section above

2.4 When clients pay a refundable deposit, they are allowed to be on two reservation lists concurrently but can only choose ONE puppy if available. If the Adopter wants two puppies, two deposits are required. Upon selecting a puppy, the Adopter will be removed from the other reservation list. The spot cannot be used for a friend or family member and cannot be transferred to someone else.

By initialing here, you acknowledge and agree to the terms in the section above







2.5 The Breeder reserves the right to use any puppy selections in any form or fashion without restriction. The Breeder also reserves the right to replace a client who chooses to remove themselves from the list with the Breeder's own selection.

2.6 The Adopter is aware that puppies can have certain common ailments upon coming home, such as urinary tract infections, parasites, ear infections, and allergy issues. While the Breeder routinely deworms and monitors for potential UTIs and ear infections, sometimes the stress of leaving the Breeder can cause issues to flare up. It is the Adopter's responsibility to treat and care for their new puppy once they leave the Breeder's care. The Adopter understands that their puppy will be going home with a free 30 days of Trupanion health insurance that must be activated within 24 hours of pick-up day.

By initialing here, you acknowledge and agree to the terms in the section above

2.7 The Adopter understands that they can be on two lists concurrently unless both lists have pups in the nursery at the same time, at which point they must choose one list. The Adopter must pick up their puppy at a mutually agreed location (due to safety concerns), pay for a nanny transport, pick up their puppy at the airport, or pay for additional fees to ship. At any time, the Breeder holds the right to cancel shipping due to safety reasons or concerns, and the client will then be responsible for arranging alternative methods of getting their puppy to them.
